Report from County Board of Supervisors:

- 1. Supervisor Brenda Adams reported that the County Offices were further along being fully opened but those offices are slimming down and more people are working remotely as COVID cases increase. Supervisor Brenda Adams urges anyone who needs County assistance to call to make sure the office is open.
- 2. **COVID**: Supervisor Brenda Adams said she had a call from David Harrison and the County Emergency Center is open. It will be open from 8:00 a.m. to 4:00 p.m., Monday through Friday. We have 26 new cases in the last two days, 103 active cases, 368 mandatory quarantined and 25 people hospitalized. We are now at 1.7% incident rate and Jack Nab at the County Health Department says that if cases continue, we will be at 2% incident rate.
- 3. **Community Task Force for Police Reform**: Supervisor Brenda Adams said that the board will meet tomorrow night and Supervisor Brenda Adams will give a report at the December town board meeting.

BOARD DISCUSSION

- 1. Supervisor Brenda Adams said that the Red Rock Fire Company will hold a Public Hearing on November 24th, 2020, at 6:30 p.m. regarding their multi-year contract status.
- 2. CNHN update: Councilperson Ginny Nightingale reported on the status of the organization. They have assisted six families to date.
- 3. Planning Board: Supervisor Brenda Adams said that the Planning Board is in need of a clerk.
- 4. Charging Station: Councilperson Terese Platten said that we need to install different technology. Currently, without cellular service to the ChargePoint, it will dispense 10 fills and then it will shut down. We are waiting for the new technology to arrive at the town hall and it will be installed by a PlugIn Stations Online (the third-party supplier to ChargePoint. Discussed both a new cell tower or cell repeaters and board is interested in researching repeaters with Verizon.
- 5. Transfer Station meeting and contract discussion: Councilperson David Patzwahl said Supervisor Brenda Adams have met the County Waste personnel to discuss a new contract. Councilperson David Patzwahl said that the new rules for the C&D permits seem to be working well. They will meet again in December.
- 6. November Election: Supervisor Brenda Adams said that 746 people voted in person, 131 people early voted, and there were 374 absentee ballots, of which 144 have not been returned. We had a total of 1,100 voters; 74% of the Town voted. We want to "Thank" and extend our

gratitude to Mr. Craig Dillion for all his preparation, to clean, set-up and work for and at this election.

- 7. Sexual Harassment training: Town Clerk, Charlotte Cowan, sent all employees the link for the sexual harassment training. Supervisor Brenda Adams would like all to take the training by the end of the month. If someone has taken the training in another context it is acceptable. The certificates of those who take the test will be sent to the Supervisor.
- 8. Veteran's Day/ November 11 at 2:00 p.m.: Supervisor Brenda Adams said that Gary Flaherty will hold a very small ceremony at the monument. He will lay a wreath at the monument and one Iraqi war veteran will be present.

ASSESSOR REPORT:

Exemptions-

All Exemption renewals will go out the first week in December and are not due until March 1, 2020.

I will be including instructions how to renew in the mailings. I will be encouraging them to be mailed in instead of coming in person.

Other-

- I am working on reviewing permits and sales in the field as usual when time permits.
- We have been working on scanning data from the physical files for a couple years when time permits.
- Assessment Data Files were turned in to the County on the 4th so the Town and County Rates can be figured in time for the printing of the Tax bills.
- I had 2 SCAR filings. One has withdrawn. The other one is still not scheduled. I am trying to find out from the courts what is going on. They were all assigned but I have not heard from the hearing officer. I do not even know who the hearing officer is.

HIGHWAY REPORT:

ACTIVITIES:

The weather once again makes front headlines. Temperature fluctuations from 60° to 16° in October produced strong winds which took down several trees and gave us some plowable snow as well.

We paved the culvert on Frisbee Street with help from the Town of Chatham. The paver, roller and knowhow were invaluable getting the job done quickly. The only thing left to do is install the guiderail to complete the project.

Sand & salt has been delivered steadily - we should be done soon. Project is finished.

Trucks were set up "winter mode" in a matter of hours but unfortunately some will have to be converted back to "repair mode". We are still working on potholes which need to be filled and

leaves out of the ditches before winter sets in.

As it turns out were unable to find a used tailgate for Truck #12. We have submitted the estimate to the insurance company which came to \$1,195.00. While we were at it, Daryl did a comprehensive review of equipment on the policy, deleting items that we no longer have and adding items that were not listed.

David gave me Mike Ryan's name & number for the roof repairs on the highway garage. Mike called and that was the last of it as of yet. –
