#### IV. Other Business

- Chair discusses potential changes to the fee schedule. Requests comments from the board.
  - Jens Braun: agrees with simplifying the schedule by not having two different fees depending on the size of subdivision.
- Town of New Lebanon approved subdivision part of which is in Town of Canaan.
  - Did not notify the Town of Canaan, Chair finds the action was deficient because Town is required under Gen Muni Law section 23-nn, at least ten days prior to a hearing.
  - Applicant will need a driveway permit, rights of way, and meet road specification of the Town of Canaan (includes pull offs every 500 ft for fire trucks and cul-de-sac for turn around).
  - Land is intended for conservancy. Will need a SEQRA, long form was received.
  - o Matter may be before this board in January.

#### Training

- o Mark DeSanctis requesting whether upcoming training (planning and sexual harassment) is mandatory.
- Chair explains that both are required for everybody. Anyone who takes the sexual harassment training at work can provide a certificate.
- o In Service training is on November 30.
- Any planning association training certificates can be forwarded to the Chair.
